Historic Home Tour 2015

Saturday, June 6th marks the date for MSL's 12th annual Historic Home Tour. Our homeowners look forward to sharing the stories and histories of their homes and gardens while guests experience their unique characteristics and architectural details.

The tour theme repeats last years', "Bridging the Architecture of the Past with the Present," by opening five homes built between 1870 and 2006. Each of these homes demonstrate recognizable architectural styles that include Arts and Crafts, Queen Anne, Victorian Italianate, Chicago Brick Bungalow, and Farmhouse. The Cook Mansion, a Victorian remodeled with a classic colonial portico, will also be included.

The Design Committee believes this tour theme is very relevant for how we view not only historic preservation, but also energy conservation in 2015. Today's building costs often prohibit constructing homes with the materials used in the past, let alone the craftsmanship required to create the intricate details found in classic architectural styles. Yet, our newer homes on the tour have captured the spirit of authentic architectural styling while incorporating the energy efficiencies that enhance the health, safety, comfort, and durability needed in modern residential buildings.

The tour booklet and wristband can be ordered online at mainstreetlibertyville.org, in advance, with a \$15 per person donation to Main Street Libertyville. The donation will be \$20 on the event day. MSL volunteers will be in Cook Park on June 6th beginning at 9:30am to distribute booklets and wristbands for pick up or purchase.

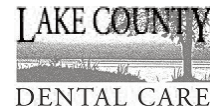
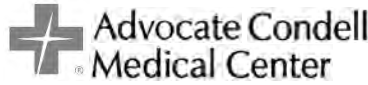

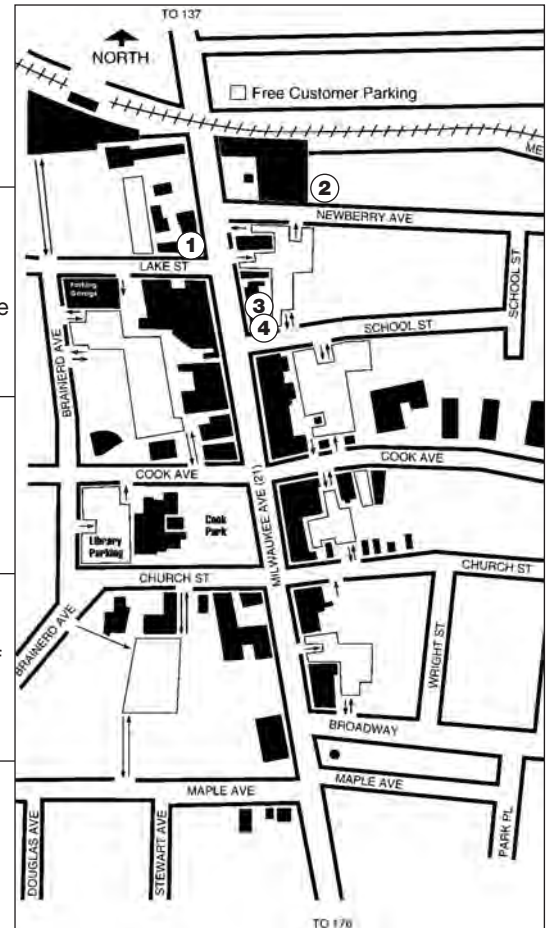
