The MainStreet Libertyville Design Committee presents the 10th Annual Historic Home Tour on Saturday, June 1st, from 10am to 2pm. Al Scott, Design Committee Co-Chair, explains that in the past we have highlighted particular architectural styles, such as Bungalows and The American Four Square. However, for our 10th anniversary, we are showcasing several homes from past tours that represent a variety of architectural styles, in addition to several homes new to the Home Tour.

Participants can walk, bike or drive the several block area to see these wonderful homes. The tour focuses not only on the historic aspects of these homes, but the personal stories and emotional connections the families have for their homes as well. Many of our homeowners have graciously offered to open their interiors, while others have invited us to their porch or garden.

Historic Home Tour Booklets, distributed by MainStreet volunteers in Cook Park, provide a tour map to the properties and tell the story of each home. Nan Grupe, Design Committee Co-Chair, added, "CNN recently included Libertyville as one of the top places to live in the United States. The continuing efforts of residents and their commitment to historic preservation contribute to the distinctive character of the village." Over forty MainStreet Libertyville Member organizations participated, providing a wide range of wines, cheeses and other delicacies to enjoy.

Survey results completed during the event revealed that nearly 70% of participants were women from outside of Libertyville; many were venturing into our downtown stores for the first time.

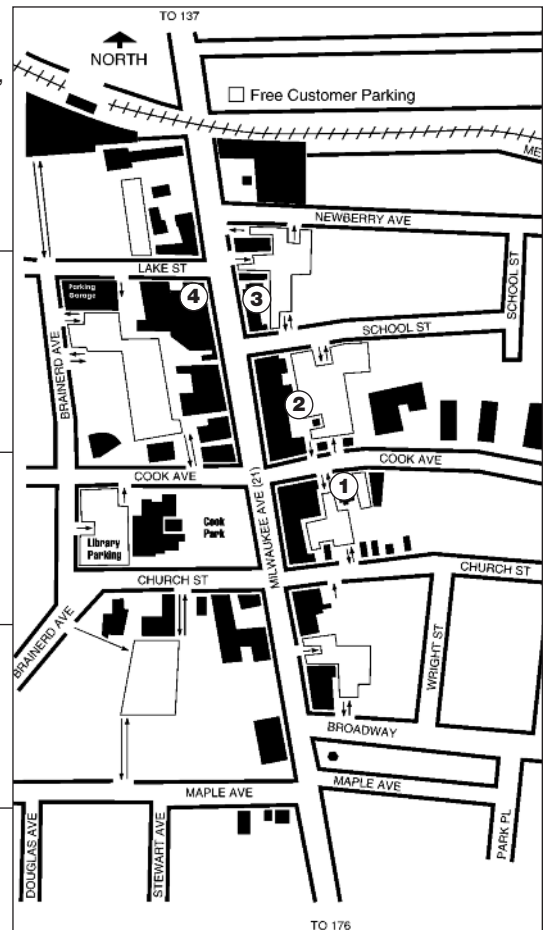
