## MAINSTREET BY THE NUMBERS Can We Count on You?

MainStreet Libertyville is a 501(c)3 nonprofit organization founded more than three decades ago by community members who worked tirelessly to transform an underutilized business district into the downtown we know and love today. Downtown Libertyville is a vibrant, walkable shopping, dining and entertainment center with significant historic architecture.

We are proud to be one of 21 organizations in Illinois designated as an Accredited Main Street America program that meets rigorous performance standards, and one of only two in the state that holds the distinction of being a Great American Main Street Award winner – an honor that only 109 communities nationwide hold today.

Our work is done with the help of community members – like you – who value and treasure our historic downtown and what it adds to our community. Each year, we develop a schedule of activities with the goal of enhancing our community's identity and heritage, fostering a center of activity and ensuring economic stability in the heart of Libertyville. This year we are offering 60 days of community and retail events including the Farmers Market, Lunch in the Park, Oktoberfest in Libertyville and Dickens of a Holiday.

We follow a time-tested model developed by Main Street America that focuses on concentrated efforts relating to design, downtown promotion, fundraising, volunteerism, community engagement and small business support to preserve and promote the downtown Libertyville.

Downtown Libertyville today reflects 34 years of grassroots organizing, volunteerism and preservation-based economic development. Since 1989, private investment in downtown

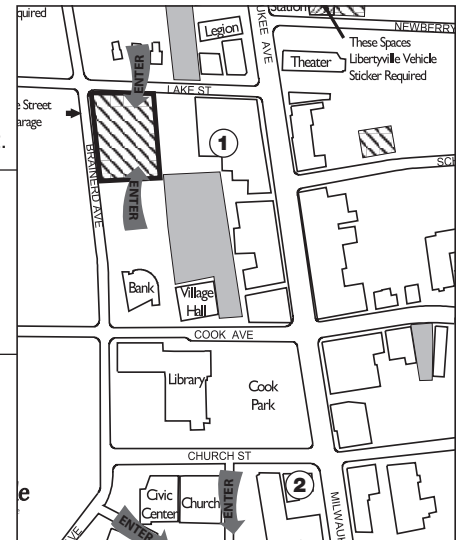
